**GABELLI EQUITY TRUST  
DECLARES \$0.3125 QUARTERLY DIVIDEND FOR ITS  
SERIES G CUMULATIVE PREFERRED STOCK**

**Rye, NY** -- The Board of Directors of The Gabelli Equity Trust Inc. (NYSE:GAB) (the "Fund") declared a \$0.3125 per share cash distribution payable on June 26, 2017 to Series G preferred shareholders of record on June 19, 2017.

The Series G Preferred Shares, which trade on the New York Stock Exchange under the symbol "GAB Pr G", were issued on August 1, 2012 at \$25.00 per share. The Series G Preferred Shares pay distributions quarterly and have an annual dividend rate \$1.25 per share annually. The Series G Preferred Shares will be callable at any time at the liquidation value of \$25.00 per share plus accrued dividends following the expiration of the five year call protection on August 1, 2017.

All or part of the distribution may be treated as long-term capital gain or qualified dividend income (or a combination of both) for individuals, each subject to the maximum federal income tax rate, which is currently 20% in taxable accounts for individuals (or zero depending on an individual's tax bracket). In addition, certain U.S. shareholders who are individuals, estates or trusts and whose income exceeds certain thresholds will be required to pay a 3.8% Medicare surcharge on their "net investment income", which includes dividends received from the Fund and capital gains from the sale or other disposition of shares of the Fund.

Long-term capital gains, qualified dividend income, and ordinary income, if any, will be allocated on a pro-rata basis to all distributions to preferred shareholders for the year. Based on the accounting records of the Fund currently available, each of the distributions paid to preferred shareholders in 2017 would include approximately 38% from net investment income and 62% from net capital gains on a book basis. This does not currently represent information for tax reporting purposes. The estimated components of each distribution are updated and provided to shareholders of record in a notice accompanying the distribution and are available on our website ([www.gabelli.com](http://www.gabelli.com)). The final determination of the sources of all distributions in 2017 will be made after year end and can vary from the quarterly estimates. All shareholders with taxable accounts will receive written notification regarding the components and tax treatment for all 2017 distributions in early 2018 via Form 1099-DIV.
