Fund Overview

This annual shareholder report contains important information about The Gabelli Media Mogul Fund (the "Fund") for the period of October 1, 2023 to September 30, 2024. The Fund invests in companies that are primarily engaged in the production, sale, and distribution of goods or services used in the media industry. The Fund specifically focuses on companies spun-off from Liberty Media Corporation (Liberty Media) as constituted in 2001, as well as in companies that resulted from the subsequent mergers of any such spin-offs or stocks that track the performance of such spin-offs or companies that resulted from subsequent mergers of any such spin-offs, and in public companies in which Liberty Media and its successor companies invest. 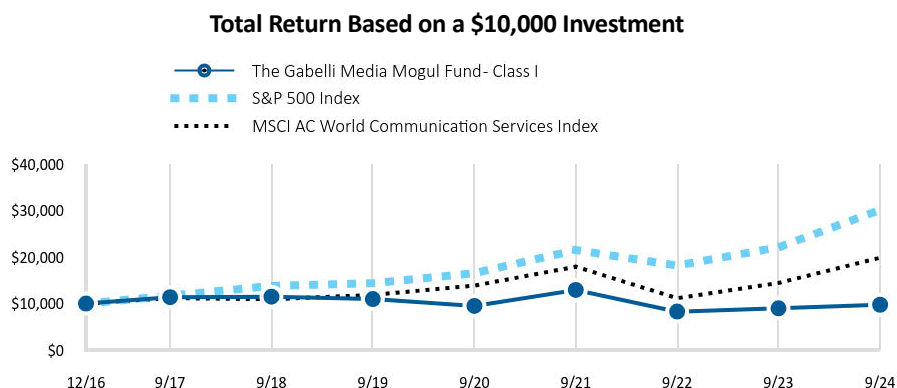

How did the Fund perform?

For the twelve months ended September 30, 2024, the Gabelli Media Mogul Fund, which is primarily focused on the Communications Services and Consumer Discretionary sectors, lagged its broad-based benchmark, the S&P 500 Index. Secular headwinds related to changes in consumer behavior and increased competition in the media and broadband connectivity sectors outweighed tailwinds in live entertainment. The companies in which the Fund invests tend to be more financially leveraged which was also a drag as interest rates rose during the period.

How has the Fund performed since inception?

The performance chart of the fund class presented reflects a hypothetical \$10,000 investment, assuming the maximum sales charge, compared to a broad-based securities market index and more narrowly based indices reflecting market sectors in which the Fund invests over a 10-year period. The chart uses total return NAV performance and assumes reinvestment of dividends and capital gains distribution. Fund expenses were deducted.

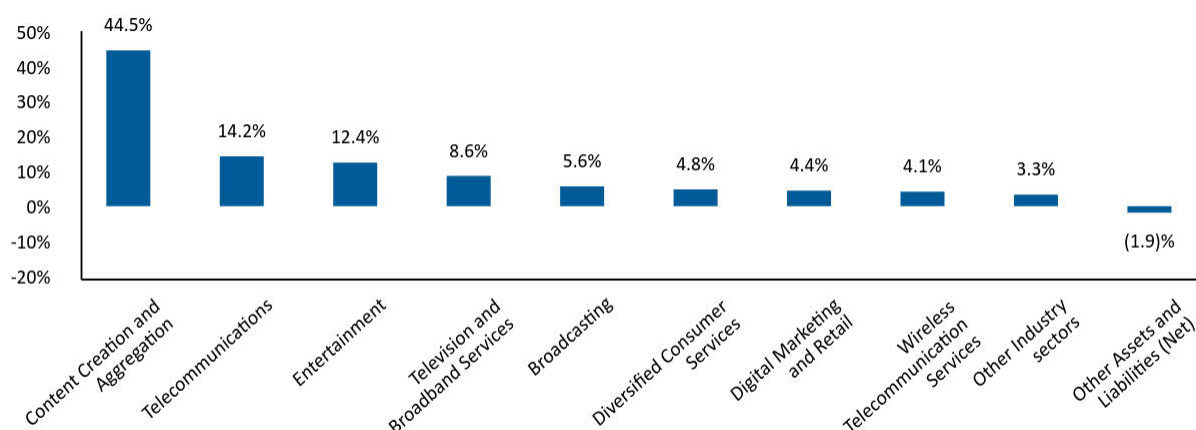
