Fund Overview

This annual shareholder report contains important information about Gabelli Gold Fund, Inc. (the Fund) for the period of January 1, 2024 to December 31, 2024. The Gabelli Gold Fund's investment objective is to provide investors with long term capital appreciation. The Fund's investment strategy is to invest at least 80% of its net assets in equity securities of foreign and domestic issuers principally engaged in gold related activities and gold bullion. In selecting investments for the Fund, Gabelli Funds, LLC (the Adviser), focuses on stocks that are undervalued, but appear to have favorable prospects for growth. Factors considered include capitalization per ounce of gold production, capitalization per ounce of recoverable reserves, quality of management, and the issuer's ability to create shareholder wealth. 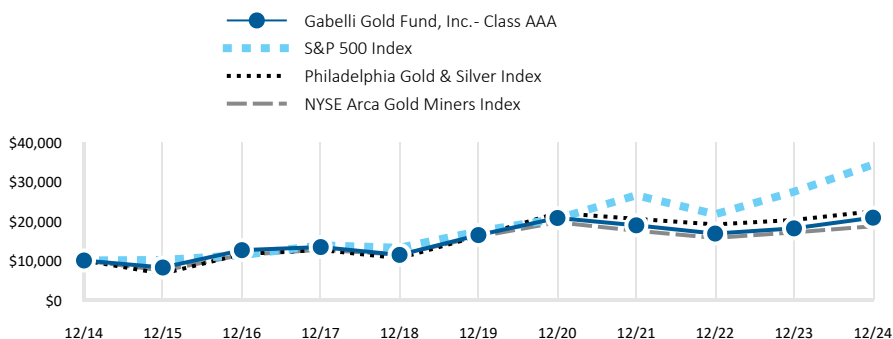
How did the Fund perform?

For the fiscal year ended December 31, 2024, the Gabelli Gold Fund underperformed its broad-based benchmark, the S&P 500 but outperformed its comparative benchmarks, NYSE Arca Gold Miners Index (GDMTR) and the Philadelphia Gold & Silver Index (XAU). Gold performed strongly for the second consecutive year. During 2024, the gold price appreciated by \$562 per ounce to end the year at \$2,625 per ounce. This is a rise of 27.2%. For the year, gold equities underperformed the gold price but this was entirely due to the woeful performance of gold equities in the fourth quarter when the XAU Index of gold stocks fell by 13.6% while gold declined a modest \$8 per ounce or 0.3%.

How has the Fund performed over the past 10 years?

The performance chart of the fund class presented reflects a hypothetical \$10,000 investment, assuming the maximum sales charge, compared to a broad-based securities market index and more narrowly based indices reflecting market sectors in which the Fund invests over a 10-year period. The chart uses total return NAV performance and assumes reinvestment of dividends and capital gains distribution. Fund expenses were deducted.

Total Return Based on a \$10,000 Investment



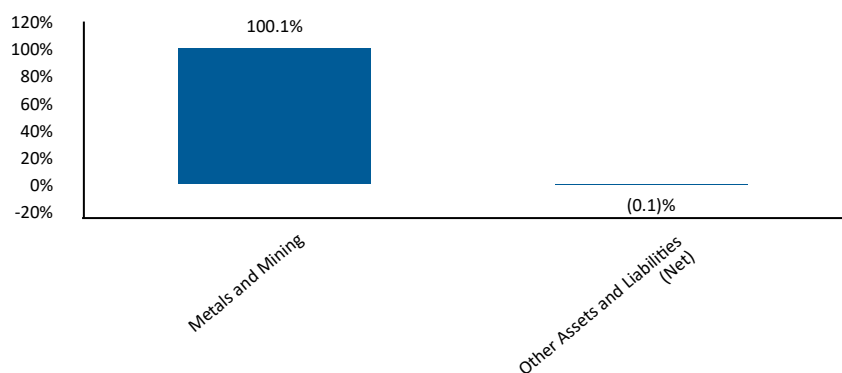
