



Effective December 31, 2021, Teton Advisers, Inc. transferred the investment management agreement for the SmallCap Equity Fund and the portfolio team that managed the Fund to Keeley-Teton Advisers, LLC, a wholly-owned subsidiary of Teton Advisors, Inc. Keeley-Teton Advisors, LLC will serve as the adviser to the Fund pursuant to an investment management agreement identical to the previous agreement between the Fund and Teton Advisors, Inc. The management and ownership of Teton Advisers, Inc. and Keeley-Teton Advisors, LLC are unchanged by this reorganization and the reorganization will not result in a change of control of either entity.

Keeley Teton Advisors is the investment adviser. *The inception date of the Fund was April 15, 1997. The Class AAA Shares' net asset values are used to calculate performance for the periods prior to the issuance of Class A Shares and Class C Shares on November 26, 2001, and Class I Shares on January 11, 2008. Notwithstanding the limitation of expenses, the actual performance for Class C and Class A Shares would have been lower and Class I Shares higher due to the different expenses associated with those classes of shares. The Adviser reimbursed certain expenses to limit the expense ratio during the period from inception. Had such limitation not been in place, returns would have been lower.
