### STRATEGY OVERVIEW

- The Gabelli Global Financial Services Fund ("the Fund") seeks to provide capital appreciation.
- The Fund invests primarily in the common stocks of companies engaged in financial services.
- The Fund seeks to purchase common stocks that are selling in the public market at
  a discount to their private market value ("PMV"). The Adviser prefers issuers that
  are well managed and strongly financed.
- The Fund can also invest in debt securities but will usually only do so when they
  offer equity like returns.


