DISTRIBUTION POLICY

Monthly Distribution \$0.08/share*

*Beginning on February 27, 2025, Class A and Class I Shares will pay a monthly distribution of \$0.08 per share. The monthly distribution for Class AAA & Class C shares is \$0.06 per share. Shareholders should be aware that a portion of the distribution may represent a non-taxable return of capital. Distributions of capital reduce the cost basis of your shares if you hold them in a taxable account. The distributions should not be confused with the yield or total return of the Fund. The distribution policy may be changed by the Fund's Board of Directors at any time.

PORTFOLIO UPDATE

The Gabelli Focused Growth and Income Fund (GWSIX) increased 2.40% in the 1st quarter of 2025, significantly outperforming the S&P 500 which declined 4.30% during the same period.

Markets rallied early in the quarter, with expectations of easing regulation and a resurgence in the IPO market. Sentiment quickly cooled due to trade and tariff uncertainty, with the new administration taking aim at trade partners through drastic tariff increases. We continue to search for companies with strong cashflows, and believe the Fund is well positioned to navigate further volatility. The portfolio has a gross dividend yield of approximately 7.2%.

AT&T Inc. (T), the second largest position in the fund, is a leading global telecommunications company with a robust portfolio spanning wireless communications, broadband, and digital entertainment services. We see the wireless business as resilient in a potential recessionary environment with a predictable subscription model that represents over 80% of consolidated EBITDA. AT&T has a current return of 4.1% and we have a PMV of \$33 using a sum-of-the-parts valuation representing 22% upside.

The Class AAA Shares' net asset values are used to calculate performance for the periods prior to the issuance of Class A Shares and Class C Shares on December 31, 2003 and Class I Shares on January 11, 2008. The actual performance for Class A and Class C Shares would have been lower and Class I Shares higher due to the different expenses associated with those classes of shares. Performance for periods less than one year is not annualized. Class A Shares (load adjusted) includes the effect of the maximum 5.75% sales charge at the beginning of the period. Class C Shares (load adjusted) includes the effect of the applicable 1% contingent deferred sales charge for shares redeemed up to and including the last day of the twelfth month after purchase. The Adviser reimbursed certain expenses to limit the expense ratio during the period from inception. Had such limitation not been in place, returns would have been lower.
