### What Changes and Why It Matters

We have converted our four remaining semi-transparent ETFs to full transparency, including renaming Gabelli Automation ETF (GAST) to Gabelli Global Technology Leaders ETF (GGTL) with an enhanced global technology mandate.

Most technology funds are U.S.-heavy and cap-weighted. GGTL takes a different approach. Managed by Portfolio Manager Hendi Susanto, GGTL targets global technology leaders with dominant market positions and structural competitive advantages. These are companies positioned to capture secular growth across semiconductors, software, cybersecurity, and IT and AI infrastructure, while maintaining meaningful exposure to companies in non-U.S. markets.

- Quality over quantity: High-conviction positions with limited competition and defensible moats
- Active opportunity: Dynamically adjusted portfolio around earnings, market events, and catalysts to capture alpha
